CAR OPERATION
 CARS HAVING A MAXIMUM GROSS WEIGHT [CAR & LADING] NOT TO EXCEED
 263,000 LBS. MAY BE OPERATED OVER THE RAILROAD, EXCEPT THAT, ON THE
 TRACK SECTIONS SHOWING A RATING LESS THAN 263, THE MAXIMUM GROSS
 WEIGHT OF CAR, IN THOUSANDS OF LBS., MUST NOT EXCEED THE RATING SHOWN.
 CARS HAVING A GROSS WEIGHT EXCEEDING 263,000 LBS. AND CARS HAVING A
 GROSS WEIGHT, IN THOUSANDS OF LBS., EXCEEDING THE RATING SHOWN FOR
 ANY SECTION OF TRACK, MUST NOT BE OPERATED OVER THAT SECTION OF
 TRACK, EXCEPT UNDER SPECIAL RULING FOR EACH CASE.
